I met this afternoon with Rebecca Shwartz Lesberg and went through the following questions with her. Please see notes and comments below.

- 1. What will be your approach to prioritization? What are the most compelling factors?
  - Comprehensive answers
  - She and sub are able to hit the ground running as they are familiar with RBRA
  - Good handle of the political and social landscape
  - Development of the adaptive management document
  - Emphasis on reaching out to stakeholders and partners, and generally casting a wide (yet specific) net, including RBRA's Board, BCDC, SF State, and others.
  - Development of stakeholder engagement plan
- 2. How will RBRA be advised about whether there are any temporary, permanent or potential impacts on recreational use of bay from specific eelgrass restoration sites and/or density?
  - Communicating with partners to have a consistent dialogue
  - Nothing should come as a shock to anyone, unless there is an unforeseen event
  - It is unlikely there will be significant impacts in the Bay because most recreation happens on top of the water, and the eelgrass project happens under the water, in the very low tide area
  - Once plants are in the ground, recreational use will see virtually no impacts, but that she would be in regular communication
- 3. How will RBRA be assured the schedule be maintained? Are there any existing or anticipated project commitments that will compete with timing resources from our partners and/or your subconsultants?
  - Bi-monthly coordination meetings with timelines
  - Schedule is expected to go as planned, except in the case of a high wind event or strom (season is May – August)
  - Communicate via email if there are any changes
  - Neither she nor sub (Keith) have any constraints on their resources that will prevent meeting timed deadlines
