

**THIRD AMENDMENT TO RICHARDSON BAY REGIONAL AGENCY
PROFESSIONAL SERVICES CONTRACT**

This Third Amendment to the Professional Services Contract is made and entered into this 14th day of May 2026 by and between RICHARDSON BAY REGIONAL AGENCY, hereinafter referred to as Agency, and ANGELA MOELLER CONSULTING, hereinafter referred to as Contractor.

RECITALS

WHEREAS, on August 19, 2025, Agency and Contractor entered into a Professional Services Contract for professional consulting services as set forth in the contract; and

WHEREAS, on October 31, 2025, Agency and Contractor executed a First Amendment to the contract for professional consulting services as set forth in the contract, increasing the maximum amount in the contract from \$4,000 to \$19,000, and extending the term of the contract to March 31, 2026; and

WHEREAS, on February 28, 2026, Agency and Contractor executed a Second Amendment to the contract for professional consulting services as set forth in the contract and extending the term of the contract to June 30, 2026; and

WHEREAS, the parties wish to continue to utilize Contractor for professional consulting services to support identified Agency funding goals for the Temporary Housing Relocation Program (THRP), by researching, analyzing, and executing proposals for public or private sources of funding, and thereby seek to extend the termination date of the contract to December 31, 2026,

NOW, THEREFORE, for and in consideration of the contract made, and the payments to be made by Agency, the parties agree to the following:

1. Time of Contract: The first sentence of paragraph 5 of the Contract is hereby amended as follows:
This Contract shall commence on August 19, 2025 and shall terminate on December 31, 2026.

2. **EXCEPT** as expressly modified by this Third Amendment, all other terms and conditions of the Contract, not specifically modified, amended or superseded herein, shall continue in full force and effect.
