

**RICHARDSON BAY REGIONAL AGENCY / PROGRESS PUBLIC AFFAIRS, LLC
CONTRACT AMENDMENT #4**

This Fourth Amendment to the Professional Services Contract is made and entered into this May 14, 2026, by and between Richardson Bay Regional Agency, hereinafter referred to as Agency, and Progress Public Affairs, LLC, hereinafter referred to as Contractor.

RECITALS

WHEREAS, on November 12, 2022, Agency and Contractor entered into a Professional Services Contract for public affairs services as set forth in the contract;

WHEREAS, on June 9, 2023, Agency and Contractor entered into Contract Amendment #1 to extend the term of the contract from June 30, 2023 to June 30, 2024 and increase the maximum amount of the contract from \$120,000 to \$210,000;

WHEREAS, on May 9, 2024, Agency and Contractor entered into Contract Amendment #2 to extend the term of the contract from June 30, 2024 to June 30, 2025 and increase the maximum amount of the contract from \$210,000 to \$300,000 plus reimbursable expenses;

WHEREAS, on May 8, 2025, Agency and Contractor entered into Contract Amendment #3 to extend the term of the contract from June 30, 2025 to June 30, 2026 and increase the maximum amount of the contract from \$300,000 to \$390,000 plus reimbursable expenses;

WHEREAS, the parties wish to continue to utilize Contractor for public affairs services and seek to further extend the time of the contract to June 30, 2027, increase the contract amount by \$45,000 for a maximum amount payable of \$435,000, and reduce the monthly payments to \$3750 as set forth in this Fourth Amendment;

NOW, THEREFORE, for and in consideration of the contract made, and the payments to be made by Agency, the parties agree to the following:

1.Paragraph 4 of the Professional Services Contract is hereby amended to reduce the maximum monthly payment required under Paragraph 4 from \$7,500 to \$3,750. Except as expressly modified by this amendment, Paragraph 4 continues in full force and effect.

2. Exhibit B, paragraph 6. of the Professional Services Contract is hereby amended as follows:

The maximum term of this Contract is through June 30, 2027, unless otherwise extended. The maximum amount payable to Contractor under this Contract for this period is increased by \$45,000 and shall not exceed

Four Hundred Thirty-Five Thousand dollars (\$435,000), plus reimbursable expenses unless contract term is otherwise extended.

2.EXCEPT as expressly modified by this Fourth Amendment, all other terms and conditions of the Contract, not specifically modified, amended or superseded herein, shall continue in full force and effect.
